1. GENERAL

1.1. SCOPE

This procedure is applicable to the DAC/NSA and to any ATM/ANS provider subject to certification in accordance with regulatory requirements mentioned in the subchapter 1.2 and defines the process to be followed by all relevant parties.

NOTE: Since the publication and applicability of regulation (EU) 2017/373, there is no longer the need for recertification audits as all certificates are deemed to be issued for an unlimited period of time subject to the service provider remaining in compliance with the applicable requirements (c.f. ATM/ANS.OR.A.025).

2. PROCEDURE

2.1. GENERAL PROCESS

The application for certification as an ATM/ANS Provider needs to be submitted by the owner(s)/accountable manager or by a person responsible for the organisation **as soon as possible but in any case, no later than 9 months before the intended date of start of operations** and shall contain all the data described in chapter 3 of this procedure as well as in the DAC-NSA Form 105-1 and DAC-NSA Form 105-2.

This application shall be completed and sent by registered mail to:

Within one (1) month from the date of receipt of the application, the DAC/NSA shall acknowledge receipt of the request by registered letter. During the next 30 working days, the DAC/NSA shall define the verification process specifying all activities to be performed and inform the applicant accordingly.

2.2. VERIFICATION (AUDIT) PROCESS

The verification of compliance with all relevant safety regulatory requirements shall be performed according to the dispositions of the Commission Implementing Regulation (EU) No 2017/373, Annex II – Part-ATM/ANS.AR.C.010 and as described in the DAC/NSA Audit Manual and will include:

- Analysis of the documents enclosed with the application;
- An on-site audit aiming to verify compliance with the regulatory requirements described in Commission Implementing Regulation (EU) 2017/373 laying down the common requirements for providers of air traffic management/air navigation services and other air traffic management network functions and their oversight.

2.3. ISSUANCE OF THE CERTIFICATE

After the verification mentioned in chapter 2.2 has proven that the applicant meets all the applicable regulatory requirements and if the certification audit does not reveal (a) Level 1 finding(s) and if for each Level 2 finding a corrective action plan has been agreed on between the ATM/ANS Provider and the NSA/Competent Authority in accordance with Annex II – Part-ATM/ANS.AR.C.020 (d), the DAC/NSA will issue a certificate as per DAC-NSA Form 105-3.

The granted certificate shall contain the information mentioned in the point 1 of the Annex II of the Regulation (EC) 550/2004 and may also include additional conditions in accordance with Regulation (EC) 550/2004, annex II, point 2, (a) to (h). The new certificate shall be valid for an unlimited duration as laid down in Annex II – Part-ATM/ANS.AR.C.020 (c).

The continued validity of a certificate is ensured through remaining in compliance with the applicable requirements of Commission Implementing Regulation (EU) 2017/373 as described in Annex III – Part-ATM/ANS.OR.A.025.

2.4. WITHDRAWAL OF THE CERTIFICATE

If the DAC/NSA finds, during its oversight activities, that the holder of a certificate no longer satisfies the Common Requirements and/or the conditions attached to the certificate, it shall act appropriately while ensuring continuity of services on condition that safety is not compromised.

Such measures may include the revocation of the certificate.

2.5. DEROGATION

By means of derogation of point 2.1 of this procedure, an ATM/ANS Provider already certified by the DAC/NSA and willing to extent/amend its existing certificate by adding an additional service shall apply (by means of DAC-NSA Form 105-2) to the DAC/NSA as soon as possible.

The DAC-NSA Form 105-1 can be sent to the DAC/NSA at a later stage (not at the time of request) but in any case, this form shall be available to the DAC/NSA audit team prior to the actions described in 2.2.

The actual date of start of operations shall be coordinated with the DAC/NSA in order to plan the verification process described in 2.2 and 2.3.

The new certificate will be issued as soon as all conditions are duly fulfilled.

3. RECORD KEEPING AND GDPR

All documents related to the application of this procedure shall be kept and stored in accordance with the relevant dispositions of the NSA/NCAA Handbook.

With regard to the application of data protection (GDPR), the NSA staff shall apply the dispositions of the NSA/NCAA Handbook as well as the *DAC-Manuel Qualité* in its current version.
